Adapted for the Middle Eastern market, all courses bring an international perspective and long-standing Austrian education and research traditions from Vienna into regional contexts and requirements.



## Smart Dubai Vision by 2020







## **Graduate Programmes - Admissions Criteria**

Master applicants require a minimum of a three-year university degree or equivalent including transcripts in a field preferably related to the desired Master studies.

#### **English Proficiency Test Requirements**

All applicants whose first language is not English must provide proof of their English proficiency level C1 according to the Common European Framework of Reference for Languages through one of the following tests taken within the last two years.

Students must obtain a score of:

- TOEFL Internet-Based Test (IBT) with a minimum score of 88 points
- TOEFL Paper-Based Test (PBT) conducted at MODUL University Dubai's Campus with a minimum score of 570
- IELTS band score 6.5 (no sub-score below 6.0)
- Cambridge English Certificate (Certificate of Advanced English): C1
- Pearson Test of English (PTE) Academic: 58 65

#### **Transfer of Credits**

Credit transfers from national and international universities are considered on the basis of how relevant prior coursework is to the course syllabus at MODUL University Dubai. The grades achieved, the level and language of the course and the number of credit hours (ECTS) will also be considered.

#### Value Added Tax (VAT)

Starting from 1<sup>st</sup> January 2018, the UAE Government will be introducing Value Added Tax (VAT) at a standard rate of 5% applicable to most goods and services in the UAE. This tax is being introduced as part of the national strategy towards building a diversified and robust economy, and the continued provision of high quality services for the country's citizens and residents.

MODUL University Dubai will comply with this Government mandate and from 1<sup>st</sup> January 2018, the standard VAT rate of 5% will apply to our programmes, courses, products and services.
