Here are eight easy steps as you're Getting Started at Adelphi.

1) GET CONNECTED!

✓ Set up your Adelphi account.

Just click the Get Started tab on the email you received from Adelphi's Office of Information Technology after you deposited, or go to the checklist at adelphi.edu/first-year and follow the instructions for the eCampus portal. You're ready to get connected with your Adelphi user name, student ID number, email account and eCampus.

Visit adelphi.edu/au2go to download AU2GO and find out all that this app offers.

2) REGISTER FOR FALL CLASSES (IN PERSON OR BY PHONE)

✓ Contact 516.877.3150 or email oasr@adelphi.edu to set up an appointment to schedule your fall classes.

Some things to do before your advisement and registration appointment:

- Complete the Language Placement exam—it's important for the adviser to know your language level to schedule your classes. Go to adelphi.edu/language for the background and to take the exam.
- Visit getting-started.adelphi.edu/academics to explore your interests, your goals and your potential career. Also, read the information about General Education requirements and electives.
- Visit admissions.adelphi.edu/ap to ensure that your AP and college credits earned in high school are reflected in your transcript so you don't duplicate any courses.
- Prepare course schedules with Option A and Option B, and be flexible about course availability.

3) FIRST-YEAR ORIENTATION—IT'S A MUST!

✓ Register at adelphi.edu/orientation and select your preferred Orientation session.

Session I: Wednesday, July 11–Friday, July 13 -or-

Session II: Tuesday, July 17–Thursday, July 19

When you register for Orientation, you'll be asked to:

- Confirm your major on the drop-down menu.
- Provide parent/guardian email addresses so the University can contact them with the link to register for Parent Orientation.

After you register, here's what you do:

- Check your Adelphi email account for your reservation confirmation.*
- Check out the list of what to bring. All meals are provided, so just pack your stuff.

**Note: All University communications are sent only to this account, so this is a good time to start using your Adelphi email.*

Whether beginning as a commuter or resident, what you'll learn at Orientation will help you feel confident, focused and comfortable as you're getting started at Adelphi. Here are just some of the things you'll do:

- Get your Adelphi photo ID—you'll need it for the gym, library, meal plan and more.
- Register your car. You can register up to two cars, so you'll need the registrations for one or both.
- Discover the many ways to get involved in campus life, especially the many student organizations.
- Become familiar with Adelphi's campus so you'll know where to go for services, programs and classes—a great stress reliever before you come in the fall.
- Find out what to expect in an Adelphi classroom.
- Get some free spirit gear and cool giveaways.
- Meet your classmates as well as current Adelphi students—you'll make new friends while having a lot of fun!
- Register for classes (if you didn't already) or make changes to your registration.

All students (both commuters and residents) stay overnight in one of Adelphi's residence halls during the two-night, three-day program. Visit adelphi.edu/orientation for more complete information.



4) HEALTH REQUIREMENTS

- ✓ **Submit the enclosed Complete Health History and Physical Examination form.**
- ✓ **Apply for the Student Health Insurance waiver (if applicable).**

Immunizations

- Complete and submit the enclosed Complete Health History and Physical Examination form, which also includes your record of immunizations, prior to your first day* of classes (and preferably before First-Year Orientation). Per New York state law this includes:
 1. Immunization record: Proof of immunization for measles, mumps and rubella (MMR)
 2. Meningococcal Meningitis Vaccination Response Form
- Use the enclosed envelope to return the form to the Health Services Center.

***Note:** You will not be allowed to attend classes and may be withdrawn from the University if this form is not submitted in the required time frame. Visit health.adelphi.edu for additional information regarding immunizations.

Insurance

- Visit health.adelphi.edu/insurance and read the insurance requirements for all international and resident students, who are automatically

enrolled and billed for the Adelphi Student Health Insurance Plan. (Commuters have the option to enroll in the plan, but are not required to do so. See enrollment dates on this website.)

- Waive the student health insurance if you already have comparable coverage** by completing the waiver form at health.adelphi.edu. To waive, visit health.adelphi.edu/insurance once the site becomes available in July. (Fall semester deadline is October 1; spring semester deadline is March 1.)

****Note:** The coverage must meet the guidelines included on the Health Services website under Insurance Requirements. Once a student enrolls, the insurance policy covers the full academic year, August 9, 2018, through August 8, 2019, and cannot be waived for partial coverage. Visit health.adelphi.edu for additional details about coverage and eligibility.

Health Services Center

During the fall and spring semesters, when school is in session, the center is open 24 hours a day, seven days a week, and it is staffed by nurse practitioners, registered professional nurses and emergency medical technicians. In addition to visits due to illness or injury, services include prescription delivery, athletic clearance, gynecological examination, health education and more.



5) WHERE ARE YOU LIVING?

On-Campus Residence Hall

- ✓ **Submit the Housing Agreement and deposit before May 1.**
- ✓ **Complete Room Selection (June 13 to June 15)**
- ✓ **Move into your room on August 24, 2018!**

- If you have not applied by May 1, submit the Housing Agreement with your housing deposit. You will be placed on a wait list for any available openings. (It's the Reserve Your Spot tab in your acceptance packet.)
- Indicate on the application if you wish to live in a special residential community (Honors College, Living-Learning Communities, The Arts District or Gender-Inclusive Housing), or contact housing@adelphi.edu.
- Check off the meal plan option on the application.

After you have submitted your Housing Agreement, here are some next steps:

- Complete the New Student Online Room Selection process at housing.adelphi.edu/new for a room and roommate assignment. If you do

not participate, our housing professionals will assign you a room.

- Contact your roommate once you receive the housing assignment letter to communicate about what each of you will bring (i.e., refrigerator, TV, etc.) so there is no duplication of items.
- For access accommodations, contact the Student Access Office at sao@adelphi.edu or **516.877.3806** for special housing needs or accommodations.

Visit housing.adelphi.edu for additional details about what to bring, residential living and the seven residence halls.

Note: Move-In Day for first-year students beginning in the fall semester is Friday, August 24, between 9:00 a.m. and 3:00 p.m.

Commuting

- Sign up for a Commuter Assistant, a student who is assigned to help with the transition into college, encourage campus involvement, communicate what's happening on campus and more. For details and to register, go to csi.adelphi.edu/commuter or sign up at Orientation.
- Join the Commuter Student Organization on MyAULife and get to know other commuters.

- Purchase a commuter meal plan, which saves sales tax and, depending upon the amount of the account, can earn bonus dollars. You can use a credit card to sign up online at dineoncampus.com/adelphi or go to Adelphi's Dining Services office, located in the University Center Café, or call **516.877.3950**.

6) FIRST-YEAR COMMUNITY ACTION PROGRAM (FCAP)

✓ **Complete the application for the First-Year Community Action Program (FCAP) on MyAULife, under Campus Links.**

- Reserve the dates August 19 to August 22 for the program in which you will stay in a residence hall at night after completing community service projects during the day.
- Plan to participate in the optional fun excursion on Thursday, August 23, to celebrate completing the community service projects.
- Look for an email with details, which will be sent to your Adelphi student email.

Why FCAP and what are the benefits? This community service program has served the surrounding area in the completion of many projects, including environmental initiatives, municipal projects, assisting the elderly and more. Students have the opportunity to:

- Get a jump start on your college experience by making new friends before classes begin.
- Meet and learn from seasoned Adelphi students.
- Volunteer at various locations and experience cooperative learning opportunities.
- Gain valuable hands-on experience.

FCAP is offered exclusively to incoming first-year students, with a limited number of openings, so students should submit the application without delay—the earlier the better.

Get involved in community service while bonding with other students—both new and student leaders—and make a difference!

Inspiring words will help guide your academic journey and your transition to college life. All first-year students are required to attend. Bring your Adelphi ID for swipe-in attendance.

Note: First-year students enrolled in the Robert B. Willumstad School of Business will attend an Orientation program from 10:00 a.m. to 11:00 a.m. in the Performing Arts Center, Concert Hall, prior to Matriculation check-in.

Spirit Day

The day kicks off with the Panther Picnic, photo booth, vendors, food, giveaways and more! So have fun with other new students, or meet some of the Adelphi student leaders. Spirited activities are planned for the entire day, including a BBQ, the student organization fair, a pep rally and more! It's a great start to being a Panther!

8) FALL SEMESTER CLASSES BEGIN: MONDAY, AUGUST 27

✓ **Check your course schedule on eCampus for assigned buildings and classrooms.**

- Open the View Textbooks link under My Registration located on the CLASS program in eCampus. Textbooks can be purchased or rented at the University bookstore, located on the lower level of the Ruth S. Harley University Center.
- Read the emails sent to your Adelphi student email—important announcements from University administration and professors are sent to this account.
- Take the “Ready Set Go” tutorial once you set up your eCampus so you can easily navigate Moodle for your courses. (Many professors use Moodle for assignments, announcements and attendance.)
- Familiarize yourself with campus parking and/or shuttle service, and allow extra time so you won't be late to class.

Access Accommodations

Students who wish to request accommodations based on a disability must file a Petition for Reasonable Accommodations form with the Student Access Office in Post Hall, Room 107.

TRANSPORTATION OPTIONS

Driving to campus:

Your car must be registered with the Department of Public Safety and Transportation, Levermore Hall, Suite 113.

- Parking decals are free and applicable for the academic year. You can register up to two cars—just bring the vehicle registration(s). (This can be done at Orientation.)
- Parking regulations: First-year and sophomore resident students have restricted on-campus parking. Visit safety.adelphi.edu/resident for guidelines.

Public Transportation:

- Adelphi University is in close proximity to the Nassau Boulevard and Mineola Long Island Rail Road stations as well as the Hempstead bus terminal. Visit safety.adelphi.edu/transportation for train and bus schedules.
- Campus shuttle service is available to these train and bus stations, plus nearby shopping. Visit safety.adelphi.edu/shuttle for the Panther Express schedule.
- The Adelphi CarShare program is available to all students who hold a valid driver's license. It's an economical option when you need a car, which you can pick up right here at the Garden City campus. So, get to that off-campus interview, visit a dentist or doctor, or just explore the area! Visit safety.adelphi.edu/enterprise for details.

GUIDE TO FINANCIAL AID

WHAT'S YOUR FINANCIAL PLAN?

Once you receive your financial plan summary (Award Letter), the Family Payment Calculator Worksheet included in your packet can help you estimate your out-of-pocket expenses for the year. HOW TO APPLY FOR FINANCIAL ASSISTANCE

Information on how to apply for financial aid is available at adelphi.edu/fafsa. A financial aid checklist for first-year students, outlining the process, is available on page 9 of this guide. A more detailed timeline of reminders and important dates is available for you at financial-aid.adelphi.edu/continuing. Contact the Office of Student Financial Services with any questions you may have concerning your financial aid and/or your billing statement.

DETERMINING ACADEMIC ELIGIBILITY FOR FINANCIAL AID

Students receiving federal and state financial aid are required to meet specific standards of academic progress. Visit financial-aid.adelphi.edu/faq, where the charts used to determine a student's eligibility for federal and state financial assistance may be found.

Student employment

As you review the Office of Student Financial Services information at financial-aid.adelphi.edu, be sure to check out the section on student employment. Having a job is not only a great way to cover personal expenses during the semester, but also a good opportunity to gain the skills and

experience that will make you stand out to potential postcollege employers. For more information about Adelphi opportunities (both on and off campus) that may enable you to use your Federal Work-Study award, contact the Center for Career and Professional Development at career-center.adelphi.edu. A student whose financial aid package does not include Federal Work-Study may also apply for on-campus employment opportunities.

FREQUENTLY ASKED QUESTIONS

Where do I go for questions about tuition costs?

Tuition, general information on financial aid, billing and payment schedules all fall under the Office of Student Financial Services. You can contact this office, located on the lower level of Levermore Hall, or visit

financial-aid.adelphi.edu, where you can find out the schedule of office hours, as well as important information about federal and state grants, federal and private loans, and links to websites with helpful financial aid tips, forms and advice. Adelphi offers many scholarships that reward a wide variety of talents and achievements, as well as need-based grants. For payment plan options, visit the site or office. The people in the Office of Student Financial Services are there to answer your questions. Ask away. You'll be surprised at how many financial aid options are available.

When is the Free Application for Federal Student Aid (FAFSA) deadline?

First-year students (freshmen) filing for the first time should file as soon as possible after October 1. January 1 is the priority filing date each year for continuing Adelphi students.

What if I didn't file the FAFSA?

If you haven't filed FAFSA by the priority deadline, it is important to do so! To file online, visit fafsa.gov. If you or your parents file your tax return electronically, we strongly recommend that you use the IRS data import function that is available at fafsa.gov. By importing your tax data directly from the IRS, you will ensure correct information on the federal FAFSA and reduce your chances of being selected for the verification process.

Note: To renew a scholarship, no FAFSA filing is necessary.

When do I get the bill?

After you register for your courses each semester, you will receive a bill.

Log on to eCampus to review your bill. The bill will take into account any anticipated financial aid that you are expecting. If you are residing on campus, review the health insurance requirements. Pay special attention to any alert messages on eCampus.

If there is an outstanding balance, explore your options, such as Adelphi payment plans, Parent PLUS loans and/or alternative loans.

FIRST-YEAR STUDENT (FRESHMAN) FINANCIAL AID CHECKLIST

File the Free Application for Federal Student Aid (FAFSA) as soon as possible after October 1. If your tax forms are not yet completed, use estimated figures. Adelphi's federal school code is 002666.

New York State residents should complete the New York State Tuition Assistance Program (TAP) application. There will be a link on your FAFSA submit confirmation page to the TAP application page. Our TAP school code is 0010.

Review your Student Aid Report (SAR) for any inaccurate items. Make corrections if needed. If estimated tax figures were used, amend your FAFSA to reflect the actual amounts. Promptly complete and submit all requested additional information and documentation.

UNDERSTANDING YOUR FINANCIAL ASSISTANCE PLAN

We're here to help!

After you have filed your FAFSA and the required documents have been submitted, you will receive a Financial Assistance Plan Summary. Review this financial aid Award Letter and all accompanying materials. This plan outlines your eligibility for the different types of financial aid: scholarships and grants (free money), student loans (which must be repaid), and Work-Study.

Some types of financial aid require the completion of additional documents:

- Federal Direct Student Loan borrowers must complete entrance counseling and a master promissory note (MPN) at studentloans.gov.
- Federal Perkins Loan and Nursing Student Loan recipients must complete a master promissory note (MPN) at studentloans.gov/myDirectLoan/launchMpn.action. You will receive an email in August to let you know when the MPN is available to sign.
- Review your TAP award at hesc.ny.gov to make sure it has our TAP school code: 0010.

If you filed the FAFSA with estimated tax figures, and have now completed your taxes, correct your FAFSA with completed tax information. If eligible, you should utilize the IRS Data Retrieval Tool (DRT) available on the FAFSA website.

Reach out to Student Financial Services for personal help exploring the various payment options that are available, such as payment plans and loans.
