# Admission

## BACHELOR OF ARTS DEGREE FOR INTERNATIONAL STUDENTS

Access to the RUFA community is not a difficult thing to achieve, but it requires commitment and determination. To access Bachelor of Arts Degree study program you will be asked to pass an admission test, that will allow us to assess your motivation and aptitude in starting the RUFA study project. In some cases, direct enrolment is possible. Admission tests vary according to the chosen course, cycle, or when transferring from another University. Here below is a summary of useful information.

### **Requirements for access**

To enrol in a Bachelor of Arts degree study program, you will be required to have achieved a diploma/school leaving certificate issued by an upper secondary education institution or another study qualification from an institution abroad deemed suitable by the Academy based on international agreements.

### **Matriculation**

Enrolment to the first year of a study program is called 'matriculation' and envisages the assignment of a 'first registration' number that will identify you as a student throughout your attendance.

### **Procedure for admission**

Your enrolment to any Bachelor of Arts degree study program depends on your passing an admission test. The admission exam is based on a logical-aptitude test (60 items in multiple choice version, 50 minutes maximum time – computer based version) and a motivational interview. The logical-aptitude test includes 20 items of cultural contents, related to the area of interest. Painting and Sculpture courses require a practical assessment such as a manual drawing. All the admission assessment is aimed to evaluate aptitudes, motivations and abilities of the candidates. For the international students, the admission exam will also be completed by Skype.

### **Language requirements for BA programs taught in Italian**





International students must have reached or surpassed the complete B1 (intermediate) level of Italian language knowledge, as established by the Common European Framework of Reference for Languages (CEFRL). In order to prove the required Italian language knowledge level, students must submit the Italian language certificate, issued by an authorized institution.

### **Language requirements for BA programs taught in English**




Students are required to submit evidence of the knowledge of the English language (B2 level).

**The application for direct matriculation is to be submitted** in the period from **6 May to 3 October 2019** directly at the main office in RUFA or via the website [unirufa.it](http://www.unirufa.it)

#### Documents for registration in admission test

-  Online application for admission
-  Photocopy of an identification document and the tax registration code
-  Higher secondary school Diploma, in the original or a self-declaration
-  Proof of payment of the admission fee amounting to € 180 (only for the September and October sessions)

Once passed the admission test, you will be required to submit your application for matriculation, within the period specified, together with the following documents:

-  Online application for matriculation
-  Two passport size photographs
-  Receipt of payment of the matriculation fee amounting to € 520 and of the regional tax amounting to € 140

## MASTER OF ARTS DEGREE

### Requirements for access

To enrol in a Master of Arts degree study program (the so-called 'laurea magistrale') you are required to have already achieved a Bachelor of Art Degree (three years) or another type of qualification achieved abroad and deemed suitable by the Academy based on international agreements.

### Procedure for admission

The purpose of the admission exam for access to Master of Art Degree is to understand your motivation and aptitude for tackling the study program you have chosen. The admission exam consists of a motivational interview and a portfolio's presentation. Portfolio must show the candidate's creative abilities, with a particular reference to the area of interest.

The candidate's evaluation will be carried out by a commission of selected lecturers.

For the international students, the admission exam will also be completed by Skype.




### Language requirements for MA programs taught in Italian
